Thank you for your interest in becoming our next Chair at ukactive.

At ukactive, our long-standing and uncompromising vision is to get more people, more active, more often. We are committed to improving the health of the nation through promoting active lifestyles. You will be someone who shares that passion for promoting active lifestyles and the benefits that this brings to the nation's physical, mental and social wellbeing. You will also recognise our significance within our sector and demonstrate a desire to help us consolidate and increase our influence and impact, as well as support our membership in promoting physical activity. With that in mind, you will have exceptional interpersonal and alliance-building skills to leverage stakeholder networks to the greatest effect, and to ensure we have a voice.



Role Profile

The role of Chair of ukactive is to provide inspiring leadership and effective governance to the organisation. The Board of Directors is responsible for setting the strategic aims, objectives and direction of ukactive, delegating day-to-day management to an executive team led by the Chief Executive, and ensuring the long-term sustainability of the organisation. The Chair ensures the Board is effective, cohesive, and collaborative and acts as an ambassador and visible champion for ukactive and the physical activity sector.

Leadership

- Lead with an inspiring and dynamic outlook, providing direction to the Board and wider organisation and challenging the Executive where necessary;
- Ensure that the organisation promotes diversity and inclusion for all its stakeholders;
- Safeguard the reputation of ukactive, upholding the values of the organisation by example;
- To support and champion a number of project/work streams, particularly aligned to the Sport England partnership;
- Commitment of enough time to ensure the duties of the role are fulfilled.

Governance

- Take responsibility for the Board's composition, development, and succession planning, supported by the Nominations Committee;
- Promote the highest standards of governance, ethics, compliance and risk management within the Board and the wider organisation;
- Ensure the Board provides appropriate influence, expert advice, support, and constructive challenge both within ukactive and the wider physical activity sector;
- Ensure the Board reviews, scrutinises and evaluates ways of working by ukactive and its members and partners;
- Ensure an annual Board effectiveness review is performed and that results from the review are acted on; and oversee the delivery of the Annual Report and Accounts supported by the Finance and General Purpose Committee.

Ambassadorial

- Act as an ambassador and visible champion for ukactive and its membership with senior, key external stakeholder groups, including political stakeholders;
- Champion the organisation to, and manage relationships with, membership/potential membership;
- Play a leading role in representing ukactive in the media and at external conferences and events, including ukactive Awards, The Conference (merger of Active Uprising and Summit), and Strategic Partner Group events;
- Visit Northern Ireland, Wales, and Scotland as part of membership engagement opportunities in the respective areas;
- Mobilise effective Government engagement and lobbying as circumstances change.

Person Specification

Part One

Knowledge and Experience

- Outstanding strategic and dynamic leadership experience, ideally with direct experience gained as Chair within another organisation and / or a public Committee of standing.
- Significant experience of engaging with Government or the political environment at a senior level, with a strong focus on influencing and partnership working: you are likely to have a track record of influencing at the most senior levels in the UK and / or in the devolved administrations.
- Ideally bring an existing level of credibility within the physical activity or health sector.
- A track record in, or at least a keen interest, in health in the UK and a passion for physical activity and the benefits that it can bring.
- Sound understanding of UK governance requirements and an independent stature.


Skills and Abilities

- High intellectual capacity and credibility (particularly in the physical activity space) and a clear and independent thinker.
- Highly effective relationship and alliance building abilities.
- Sound judgement with high capacity for self-reflection.
- Outstanding verbal and written communication skills with excellent media and spokesperson abilities.
- Has the capacity to support both Board and Executive development.

Part Three

Personal Style and Attributes

- Dynamic leadership style that guides and inspires the Board and Executive to fulfil their respective responsibilities.
- A natural networker who secures confidence immediately, has a diplomatic style that will galvanise support for ukactive's work.
- Collaborative approach with excellent interpersonal skills.
- Drive and enthusiasm for the physical activity and health sectors and a strong personal commitment to ukactive's mission and values.



Terms of Appointment

Time commitment

The role requires up to 2.5 days a month. This includes:

- Attendance at quarterly Board meetings - 2-3 hours in length. These are currently held remotely however this is anticipated to change back to holding a number of these at the organisation's Holborn office.
- Chairing of Nominations Committee, and member of Remuneration and Finance Committees. Meetings are held remotely on a 6 monthly (Nominations/Remuneration Committees) and quarterly (Finance Committee) basis.
- Chairing of AGM (only when required for governance changes).
- Visiting Northern Ireland, Wales, and Scotland as part of membership engagement opportunities in the respective areas.

Remuneration

The role is remunerated at £20,000 per annum.

Length of appointment

All Board appointments are for an initial 3-year term, renewable to up three times for a maximum of nine continuous years.

Equality, Diversity and Inclusion

ukactive is committed to championing equality, diversity and inclusion throughout all aspects of the organisation's work. As part of this the Board has made a commitment to achieving greater diversity.
