ABOUT US

The Royal Air Force Charitable Trust Enterprises (RAFCTE) is the trading arm for the Royal Air Force (RAF) Charitable Trust, one of the major military charities in the UK. The RAF Charitable Trust is focussed on promoting the RAF and inspiring young people to fulfil their potential in air, space, and technology. At the heart of the Trust's work is the Royal International Air Tattoo. Welcoming over 200,000 visitors every year, The Tattoo is the world's largest military airshow. This family friendly show is also a unique annual networking and business forum for the most senior aerospace political, military and industry leaders from across the world.

The origins of the Royal International Air Tattoo stretch back to an airshow first held at North Weald Airfield in 1971. Inspired by two air traffic controllers, Paul Bowen and Tim Prince, this modest event was organised wholly by volunteers. Over the years this volunteer force has grown into an army, more than 1,500-strong, many of whom support the event year after year and who bring with them a wealth of aviation and event-management experience that has helped The Tattoo grow into the enormous global event it is today.

Owing to the global Covid pandemic, The Royal International Air Tattoo was not held for two years. Following a sell-out event in 2022, RAFCTE is now able to focus on innovation and growth for its portfolio of services, and to explore ways in which it can expand its revenue and diversify to reflect developments around space, digital technology, and environmental sustainability. It also needs to facilitate the growth of the Charitable Trust as it grows in reach and influence.

As its parent charity, the RAF Charitable Trust benefits from the profits generated by RAFCTE. The Company's events and activities therefore provide income to foster a passion for aviation and engineering in young people and promote the Royal Air Force. Since the Trust was established in 2005, it has made grants totalling millions of pounds to a diverse range of initiatives including providing engineering and flying scholarships as well as adventurous training grants. The Charitable Trust is seeking to grow its reach and impact, and its new strategy is planning for significant growth.

THE ROYAL AIR FORCE CHARITABLE TRUST'S MISSION IS:

"To Promote the Royal Air Force and Inspire young people and RAF personnel to fulfil their potential in air, space, and technology."

We do this by:

- Staging the Royal International Air Tattoo and other similar activities.
- · Giving financial grants to satisfy the Trust's objects.
- Funding scholarships and other awards.
- · To raise funds for, and promote the work of, the Royal Air Force Charitable Trust to enable it to meet its objectives.

The Trust gives grants directly to groups, but also uses partner organisations to maximise reach and utilise expertise. Every year is slightly different as partnerships are developed over time and demand for grant types vary. Some of our highlights include:

- Awarding £6.7 million in grants since 2005, focussing on STEM projects and flying and engineering scholarships with the aim of inspiring young people, providing them with opportunities to explore futures in air, space and technology.
- Providing a year-long STEM competition for 300 primary schools, culminating at RIAT each year.
- Since 2005, funding 180 Junior Ranks Pilot Scholarships, giving young members of the RAF an insider's view of aviation.
- Sponsoring the Scouts Air Activities badge, awarding 58,000 badges in 2022.
- Inspiring 40 engineer leaders of the future by funding Arkwright Engineering Scholarships for their sixth form studies.

BOARD OF RAFCT

In 2020 Air Marshal Phil Osborn was appointed Chair of the Royal Airforce Charitable Trust.

The Chair of RAFCTE is also a member of the RAF Charitable Trust and represents the Company at Trust board meetings.

Job title: Chair

Role purpose: You will lead the Board of RAFCTE, and by implication RAFCTE.

MAIN RESPONSIBILITIES:

You will line manage the Chief Executive, ensuring that they are both supported and held to account for achieving the strategic objectives of the Company and the Group, whilst respecting the distinctive roles of the Executive and Chair. You will also mentor the Chief Executive, ensuring that they are developed within their role.

You will work with the Chief Executive to ensure that:

- Board meetings are well situated and planned.
- Board interactions are informed, inclusive and respectful, as well as appropriately challenging.
- Board decisions are both timely and then implemented fully.

You will maintain regular contact with the Trust Chair and the Chief Executive, fostering an open relationship where each can speak freely about concerns and challenges and bringing commercial acumen to the achievement of charitable objectives. You will also develop appropriate contacts with all major stakeholders including RAFCT Trustees, the Royal Air Force, the UK Ministry of Defence, the United States Air Force, international Air Chiefs and Air Forces, and industry suppliers to the aviation sector, as well as the legion of volunteers and aviation enthusiasts upon which the Tattoo depends.

You will have a deep understanding of RAFCT and its wider objectives, and hence shape and drive the pivotal support role of RAFCTE at board level, and working with the CEO and the executive team. In this, you will continue to grow the Company's support to RAFCT, creating opportunities for transformation of services. You will also lead the development, innovation, and delivery of the Royal International Air Tattoo so that it remains attractive and relevant as a world class event for its visitors, stakeholders, and sponsors in the 21st Century.

TERMS OF APPOINTMENT

TENURE

Three years initially with the option to renew for a further term subject to review.

TIME COMMITMENT

The Chair is also expected to have:

- Regular routine meetings with the RAFCTE Chief Executive and the RAFCT Chair.
- Liaising with other Board members and Trustees as required.

Additionally, the Royal International Air Tattoo takes place in July annually at RAF Fairford and hence, with the RAFCT Chair, you will wish to be present over the key preparation and execution period of the event.

LOCATION

A hybrid of home working and Fairford, Gloucestershire.

REMUNERATION

There is no financial remuneration associated with this role, although expenses for travel and subsistence may be claimed.
