Today, Locala provides services in Kirklees, Bradford, Calderdale, Stockport and Tameside and employs nearly 1500 colleagues, who are all committed to delivering the very best services to patients. Our team are part of the community and have often cared for generations within the same family. We continue to be part of the NHS family, deliver care under the same ethos and our staff enjoy the same terms and conditions.

We are a not-for-profit community healthcare provider and proud to provide a variety of NHS and local authority services to care for and support people of all ages where they live. We work closely with GPs, social services, other local NHS organisations, local authorities and the third sector to deliver a co-ordinated approach to care and support. REMUNERATION AND TIME COMMITMENT


This role attracts £36,000 per annum for the equivalent of up to 10 days per month.
