### 7 from the Green Group



# Our leadership and organisation

Operationally the council is organised into four directorates, commissioning and delivering hundreds of services. The directorates are:

City Services Corporate Services Families, Children and Learning Housing, Care and Wellbeing

The day-to-day leadership and management of council operations, such as managing council resources, commissioning and providing services, are delegated by councillors to the Corporate Leadership Team (CLT).

The team is formed by each corporate director and led by the Chief Executive, with other council officers or partners invited to attend when needed.

The Director of HR and Organisational Development and Chief Finance Officer are also permanent members of CLT.

They meet weekly and work collaboratively and with stakeholders to:

ensure good corporate governance, collaborative working and performance management develop corporate strategies and deliver the Council Plan

implement the council's policies and priorities

### **Leadership Network**

In this role you will be an active member of the council's Leadership Network and help drive its agenda.

The Network consists of the top 100+ senior managers in the council, including the Chief Executive, directors, assistant directors and heads of service.

This council-wide network contributes to the development of organisational strategies that support the council's overall strategic vision and corporate priorities, collaborates on cross-cutting work, strengthens leadership capability and capacity, and provides support and challenge to each other.


