## About MND and the work of the association

Motor neurone disease (MND) is a fatal, rapidly progressing neurological condition affecting more than 5,000 adults in the UK at any one time. The disease causes messages from nerves (motor neurones) in the brain and spinal cord that control movement to gradually stop reaching the muscles, leading them to weaken, stiffen and waste.

The result is that people become locked in a failing body, unable to move, talk and eventually breathe. Some may experience changes in thinking and behaviour, with a proportion experiencing a rare form of dementia. MND does not usually affect senses such as sight, hearing and touch.

MND kills a third of people within a year and more than half within two years of diagnosis. It affects people from all backgrounds and a person's lifetime risk of developing MND around 1 in 300. Today six people will be diagnosed and six will die from MND. There is no cure.

The MND Association focuses on funding research, improving access to care and campaigning for people living with or affected by MND in England, Wales and Northern Ireland. Our network of members provide information and support for people with MND, their families and carers. We fund and promote research that leads to new understanding and treatments and brings us closer to a cure. We campaign and raise awareness so the needs of people with MND are recognised and addressed by wider society.



### **Role Purpose**

To act as a Non-Voting Member of the Engagement and Income Committee. The overall purpose of the Engagement and Income Committee is to provide governance and scrutiny on the strategic direction of the Association's engagement and fundraising work.

The Committee Subject Matter Expert (SME) plays a critical role in providing specialised knowledge and expertise to support the decision-making and strategic direction of the Committee.

### **Main responsibilities**

Provide Expert Guidance

- Offer expert advice and insights on specific areas such as engagement and income generation.
- Serve as valuable resource for the Committee on technical or specialised issues, offering evidence-based recommendations.

#### Support Decision Making

- Attend Committee meetings (in-person or virtually) and contribute to discussions by offering expert opinions on relevant topics.
- Help the Committee understand complex issues and assist in evaluating potential solutions or strategies based on expert knowledge.

#### Contribute to Strategy Development

- Provide input to the development and refinement of the Association's strategic initiatives, ensuring that plans align with the latest research, trends, and best practices in the field of MND and care services and research.
- Assist in identifying emerging trends and innovations that could impact the Association's work and future direction.

#### Collaborate with Committee Members

- Work closely with other Committee members to share knowledge and build consensus on recommendations and decisions.
- Foster collaboration and open communication, ensuring that all perspectives are considered and integrated into Committee planning.



#### Monitor Industry Developments


- Stay current with developments in your area of expertise, including research, policy changes, and technological advancements, and communicate relevant updates to the Committee.

#### Location


Meetings are predominately virtual. Any in person meetings will be held at either our Northampton or London offices.
